MENTAL HEALTH CARE AND PATIENTS VICTIMIZED BY ABUSE, FRAUD, NEGLIGENT CARE OR OTHER MISCONDUCT.

RESOLUTION 4/9/20 - 2019-8

WHEREAS, proper mental health care services can be vital to efforts to rehabilitate individuals who are suffering from severe mental illness;

WHEREAS, in many cases access to mental health care services is vital for individuals who struggle with a mental illness to become healthy contributing members of their family and/or community;

WHEREAS, a community directly benefits when it has effective local mental health care services providers to assist individuals suffering from mental illness;

WHEREAS, individuals suffering from mental illness are often vulnerable and require the caring, ethical and compassionate care while in treatment;

WHEREAS, the Kingsburg Tri-County Health Care District ("**District**" or "**KTHCD**") does not itself provide direct services to mental health patients, and has no legal duty or legal authority to investigate or report suspected cases of fraud, abuse, negligent care or other similar misconduct toward mental health patients;

WHEREAS, despite the KTHCD's lack of regulatory authority over mental health services and providers, financial fraud by mental health services providers can result in valuable resources being deprived from those who need mental health care, and should be reported to the appropriate authorities;

WHEREAS, any instances of known abuse, harm or negligent care occurring in the context of mental health care services to treat individuals with mental illness should be reported immediately to the appropriate authorities;

WHEREAS, it is the responsibility of mental health services providers, as compassionate members of the community, to assure proper mental health care services are being delivered toward the goal of rehabilitating mentally ill individuals, without subjecting such patients to any form of known abuse, harm or negligent care;

WHEREAS, when allegations and/or evidence exists of abuse, harm or negligent care occurring in the context of mental health care services, those mental health service providers should be investigated by the appropriate authorities and held accountable for their role, in order to deter and curtail further harm to prospective and existing mental health patients;

WHEREAS, the District supports the idea of lawfully reporting known or reasonably probable instances of financial fraud, abuse or negligent care occurring in the context of mental health care services so that they can be fully investigated by the appropriate authorities, and the District will provide on its website the contact information for the Office of the Patients' Rights Advocate for each county having territory within the boundaries of the District;

WHEREAS, the purpose for reporting is to protect individuals seeking mental health care services from further harm and to encourage the use of those mental health care resources which provide competent, ethical and effective rehabilitation services; and

WHEREAS, laws which are intended to protect individuals reporting wrongdoing by mental health service providers may be listed on the District's website, including any which may prohibit retaliation, intimidation or impediments directed toward any person reporting wrongdoing.
