### Item #1: Call to Order and Roll Call

The meeting was called to order by Chairman Arlie Rogers at 4:03 p.m. Members Rogers, Knutson, Sanders, Dix and Nelson were present. There was a quorum to conduct business.

### Item #3: Consideration, review and potential action on applications for district grants

Grant applications from the following organizations were discussed:

- 1. Young Life Jr. High Campership Funds
- 2. Kingsburg Joint Union High School District Vape Detectors and Fill Stations
- 3. Pet Rescue of Unwanted Dogs (PROUD) Medications, Spay and Neuter, Veterinary Emergency Surgery

- 5. Kingsburg Fire Department Ambulance Replacement
- 6. Kingsburg Fire Department Public Access AED/Community CPR Program
- 7. Kingsburg Fire Department Ambulance Equipment Program
- 8. City of Kingsburg Athwal park Improvement Project Phase 2
- 9. Fresno New Creation Ministries, Inc. Counseling Services to Clients in Health Care District
- 10. Mission Supply Line DBA "The Landing" Life Coaching

Additional discussion was held on number 4 - Safe Harbor Homes and Services. The board would like Bill Matthews with Safe Harbor Homes and Services to attend the June 2020 meeting to further discuss the needs of his facility. Shereme Watson will make the necessary arrangements.

Addition discussion held on numbers 5, 6, and 7: Kingsburg Fire Department – Member Nelson presented each board member with copies of the 2019-2020 City of Kingsburg budget, as well as Measure E funding in relation to grant requests presented by the Kingsburg Fire Department. He had questions on where revenue generated by the ambulance was being spent, per the budget. Fire Chief Dan Perkins called into the meeting and explained that revenue listed on the 2019-2020 budget was what could be recouped if all ambulance billing was fully paid. He stated that out of the nearly \$300,000 shown as revenue, only about \$950,000 of that amount is ever actually received. Member Nelson also questioned why the police department received much more of Measure E funding than the fire department, and once again, Chief Dan Perkins explained that the police department needed new resources even more so than the fire department did.

Additional discussion was held on number 10 – The Landing. The grant request was for a threeyear period of \$37,500 for each year, but the board discussed the grant being for 1 year, in the amount of \$37,500.
